FISH AND OTHER MARINE PRODUCTS*

Article 1

Fish and other marine products listed in Table 1 are covered by the provisions of the Agreement, except as otherwise provided for in Article 3.

Article 2

Upon entry into force of the Agreement, the Parties shall abolish all customs duties on imports of products listed in Table 1 originating in an EFTA State or in Hong Kong, China, unless otherwise specified in Article 3.

Article 3

Switzerland may maintain customs duties on imports of products originating in Hong Kong, China listed in Table 2.
