COMMITMENTS OF NORWAY ON GOODS ORIGINATING IN INDIA

The following terms and conditions apply to the tariff commitments granted by Norway to India in accordance with this Annex:

- (a) For goods originating in India referred to as “NAMA” (Non-Agricultural Products) in column 3, Norway shall, upon entry into force of this Agreement, eliminate all import duties and charges having equivalent effect to import duties, as set out in columns 4a and 4b.
- (b) For goods originating in India referred to as “AG” (Basic Agricultural Products) in column 3, Norway shall apply import duties as set out in columns 4a or 4b.
- (c) For goods originating in India referred to as “AG/PAP” (Processed Agricultural Products) in column 3, the following provisions apply:
 - (i) In order to take account of differences in the cost of the agricultural raw materials, the duty, levied upon import, shall be based on, but not exceed, the differences between the domestic price in Norway and the world market price of the agricultural raw materials incorporated into the products concerned.
 - (ii) Subject to the provisions in subparagraph (i), Norway shall accord for products defined as AG/PAP in column 3 in the table, originating in India, the same treatment as given to the European Union (EU)¹. The commitments set out in the table for PAP are the same concessions as granted to the EU as of 1 January 2023. If the commitments for these products are changed in the agreement between Norway and the EU, India will simultaneously get identical commitments.
 - (iii) Norway shall publish the applicable import duties for processed agricultural products on the Website of the EFTA Secretariat in the English language. Calculated duties and tariff reductions for products marked by a star (*), based on historical imports from all free trade partners to Norway for the last 3 years, will be part of the notification.
- (d) For products referred to as “NC” (not covered) in columns 4a or 4b, no commitments related to import duties are granted by Norway.
- (e) Norway shall, based on an end-use criteria, accord duty-free market access to fish feed and raw materials for making fish-feed originating in India.

Norway reserves the rights to amend possible technical errors.

DECLARATION BY NORWAY ON THE GSP SYSTEM FOR AGRICULTURAL PRODUCTS

Recalling that Norway historically has granted improved market access for developing countries, Norway will maintain its GSP-system for India, on an autonomous basis, in parallel to the free trade agreement for all agricultural products.

Norway commits to grant India GSP-preferences as long as India is on the OECDs DAC List of ODA recipients and part of the Norwegian GSP-system.
