- 2. Procurements conducted under the Public Procurement (Preference to Make in India) Order 2017 or any other order issued by the Central Government, as amended from time to time.
- 3. Procurements related to construction projects or any infrastructure projects.
- 4. Procurements relating to health care sector including medical devices, pharmaceutical products, therapeutics, diagnostics.

- 5. Procurements of agricultural products made in furtherance of agricultural support programmes and human feeding programmes (e.g., food aid including urgent relief aid).
- 6. Procurements of goods and services for the establishment and operation of embassy buildings outside the territory of the India.
- 7. Procurements by any entity not covered by this Chapter.
